INVITATION FOR BIDS(IFB)

Under the housing infrastructure component of the ongoing Indian Housing Programme (IHP) and completed Ministry housing projects, the Ministry of Plantation and Community Infrastructure has allocated funds for the design, technical consultancy, and implementation of water supply projects for the financial years 2025/2026. Accordingly, the Chairman of the Procurement Committee, Plantation Human Development Trust (PHDT), on behalf of the Ministry of Plantation and Community Infrastructure, invites sealed bids from eligible and qualified bidders for the works described below. Bidding will be conducted through National Competitive Bidding (NCB) procedures in accordance with the Government Procurement Guidelines 2024.

2. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the qualifications and requirements specified in the Bidding Documents.
3. The Bid Security shall be either: (a) a cash deposit amounting to 0.5% of the Engineering Estimate (a copy of the receipt must be attached), or (b) a Bank Draft amounting to 1% of the Engineering Estimate (Direct Estimate Cost). The Bid Security must be valid for 105 days for above 5 Mn projects and 77 days for below 5 Mn projects from the bid closing date.
4. Sealed bids shall be delivered in duplicate, with separate envelopes and the project name written at the top left-hand corner, and addressed to the place of **submission on or before 22.01.2026 at 11.00 hours**. Bids will be opened soon after closing in the presence of bidders or their representatives who choose to attend. Late bids will be rejected.
